The footnote contains the number of the citation followed by a period and then the citation itself. The citation always includes the author's name and the title of the text, and it always ends with a period. Full notes also include all the relevant publication information (which varies by source type).

Footnotes are notes placed at the bottom of a page. They cite references or comment on a designated part of the text above it. For example, say you want to add an interesting comment to a sentence you have written, but the comment is not directly related to the argument of your paragraph. In this case, you could add the symbol for a footnote.

Citation numbers should appear in sequential order. If using endnotes, numbered notes will appear on a separate, endnotes page at the end of your document and before the bibliography page. The page should be titled Notes (centered at top). Footnotes must appear at the bottom of the page that they are referred to.

Footnotes vs. Endnotes Authors can also use endnotes to avoid disrupting their writing with extraneous information. As with footnotes, the presence of an endnote is identified in the main text with a small superscript number.

A footnote is a notation at the bottom of the page in a printed document. Footnotes are usually presented in smaller print than the dominant text, and they are used for a variety of purposes. Footnotes may also appear on their own page after the References page in your document. Center and bold the word "Footnotes" at the top of the page. Indent one tab (or five spaces) on the first line of each footnote. Put a space between the footnote number and the footnote itself. Then, follow normal paragraph spacing rules. Double space throughout.

If the footnotes are compiled on a separate page, the title "Footnotes" should be centered at the top of the page. Avoid formatting the title with bold, italics, underlining, or quotation marks. Indent the first line of each footnote five spaces from the left margin, and double-space the entire page.

In most cases, a footnote occurs at the end of the sentence with the information that you want to cite or discuss. Some style guides provide for a number after the closing punctuation, followed by a period. In others, superscript numbers are preferred. You'll typically only have one footnote per sentence.

A footnote is a reference, explanation, or comment <sup>1</sup> placed below the main text on a printed page. Footnotes are identified in the text by a numeral or a symbol. In research papers and reports, footnotes commonly acknowledge the sources of facts and quotations that appear in the text. "Footnotes are the mark of a scholar," says Bryan A. Garner.

Endnotes and footnotes in MLA format are indicated in-text by superscript Arabic numbers after the punctuation of the phrase or clause to which the note refers: Some have argued that such an investigation would be fruitless. <sup>6</sup> Scholars have argued for years that this claim has no basis, <sup>7</sup> so we would do well to ignore it.

The footnote should look like this: J.D. Salinger, *Catcher in crops*, Iskry, London 1961, p. 69. As you can see at the beginning the name of the author with the initials of the name, then the title in italics (NOT in quotes!), Then the name of the publishing house, place and year of publication (no comma) and the page from which the quote was taken.
